A RESOLUTION ACCEPTING THE AMOUNTS AND RATES AS DETERMINED BY THE HAMILTON COUNTY BUDGET COMMISSION AND AUTHORIZING THE NECESSARY TAX LEVIES AND CERTIFYING THEM TO THE COUNTY AUDITOR

WHEREAS, this Council, in accordance with the provisions of law, has previously adopted a Tax Budget for the next succeeding fiscal year commencing January 1, 2022; and

WHEREAS, the Budget Commission of Hamilton County, Ohio, has certified its action thereon to the Golf Manor Village Council, together with an estimate by the County Auditor of the rate of each tax necessary to be levied by this Council and what part thereof is without, and what part is within the ten-mill tax limitation.

SECTION I. The amounts and rates, as determined by the Budget Commission in its certification, as set forth on the attached Schedule A, are hereby accepted.

There is hereby levied on the Village of Golf Manor's tax duplicate the rate of each tax necessary to be levied within and without the ten-mill limitation, as detailed on attached Schedule A, which Schedule A is adopted by reference as if fully restated herein.

SECTION III. The Clerk of Council is hereby directed to certify a copy of this Resolution to the Hamilton County Auditor.

SECTION IV. This Resolution shall be in full force and effect from and after its passage.
