Pledge of Allegiance & Roll Call for Quorum	Mayor Stefan Densmore			The Village Council convened a Special meeting on Monday, April 12, 2021 at 7 PM by video conference with Mayor Stefan Densmore presiding. The Mayor previously called this meeting as a special meeting.  This remote access meeting was allowed by emergency legislation adopted by the Ohio General Assembly and approved by the Governor. The emergency legislation added language to RC Section 121.22 allowing public meetings by telephone or video conference during the current pandemic and the declared State of Emergency. As required by the statute, notice of the video meeting was publicized more than 24 hours in advance to allow public access. The public was also given back up numbers to call in the event there were difficulties accessing the meeting by Zoom video. This Notice of Meeting was posted on the Village's website and a similar Notice was sent to various media outlets. Village Administrator	Ron Hirth	Report	Greg Dale, Dale, McBride, and Clarion	Development of Strategic Plan: Greg Dale, Dale, McBride, and Clarion-Partner. The Village has contacted the firm to discuss actions needed to create a strategic plan based on the needs and wants of the Village. Mr. Dale began his discussion with a short presentation outlining the strategic planning process. Mr. Dale stated that a strategic plan's purpose would be to identify the Village's priorities, and establish a clear and efficient process for implementation. Ideally the strategic plan would be aspirational, long-ranged and be annually reviewed. Further Mr. Dale stressed that the final strategic plan will be the result of a series of focus group and one-on-one meetings. Because of this format the final report will be entirely community driven.

The Community navigators stated that their first goal for the program is to establish an effective communication strategy to the broader community. Once the strategy is established the program

Of this amount 5,000 respected the speed limit and an additional 2,721 moved within the "tolerable" range. The highest speed during this period was 52 mph.</li> <li>As for the Wiehe Road sign the average speed was 28 mph with the highest speed being 58 mph. Chief Campbell suggested that the high speeds recorded at both locations could be the result of Police and/or Fire and EMT vehicles responding to emergencies. Chief Campbell will continue to dig into the numbers.</li> </ul>
