The Mayor previously called for this meeting as a special meeting to conduct business of the Village. This remote access meeting was allowed by emergency legislation adopted by the Ohio General Assembly and approved by the Governor. The emergency legislation added language to RC Section 121.22 allowing public meetings by telephone or video conference during the current pandemic and the declared State of Emergency. As required by the statute, notice of the video meeting was publicized more than 24 hours in advance to allow public access. The public was also given back up numbers to call in the event there were difficulties accessing the meeting by Zoom video. This Notice of Meeting was posted on the Village's website and a similar Notice was sent to various media outlets. New Business			WE Thrive Strategy	 We Thrive community navigators were introduced. They are Jaclyn Threadgill and Evan Konc. Both are residents of the Village. The Community navigators stated that their first goal for the program is to establish an effective communication strategy to the broader community. Once the strategy is established the program will begin to focus on improving the health and wellness of the community by developing a deep understanding of their needs. Additional residents have communicated their interest in joining. The next meeting will be on 5/6/21 at 7 pm.
			Code Enforcement Strategy	 The Village has recently hired Jim Puthoff as the Village's Code Enforcement Official. Mr. Puthoff is the former fire department chief for the Little Miami Joint Fire and Rescue District and Golf Manor and has a wealth of experience and knowledge with the fire and building codes. Mr. Puthoff stated that his initial focus will be on improving and updating the residential property maintenance and zoning codes. Mr. Puthoff will also work with Ofc. Matthews on cases of common interest with the goal to begin utilizing the Hamilton County Housing Court for difficult cases.
			Master plan development	The Village has identified McBride, Dale, and Clarion as a potential consultant to aid the Village in developing a strategic plan. The firm's Principal, Greg Dale, is representing the firm. Mr. Dale advised that a point of starting would be to work with stakeholders of the Village to craft a long-term strategy to implement the needs and desires of the Village. Mr. Dale further stated that whatever strategic plan is developed would be derived entirely based on the feedback of the broader community and key stakeholders. Mr. Dale advises identifying who the key stakeholders and organizations are in the Village, and develop a meeting strategy to gain their input.
