The following legislation is on the Agenda for the April 26, 2021 meeting of Village Council:

**1. Resolution No. 2021 - 4**

**A Resolution Authorizing The Administration To Apply For And Administer Funding From The American Rescue Plan Act Of 2021**

Congress recently enacted the American Rescue Plan Act of 2021 which allocated funds to local communities. The rules and regulations concerning expenditures continue to evolve and we do not know at this point what additional documentation the Village may be required to execute to apply for these funds. This Resolution will authorize the Administration through either the Village Administrator or the Village Fiscal Officer to execute the documentation necessary to participate in the funding, and to budget and expend those funds as appropriate consistent with the rules and regulations which are being developed. Additional appropriations may be required to adjust the budget specifically for these expenditures, but this gives the Administration the maximum flexibility to participate in the program if expedited action is required.

**2. Ordinance No. 2021-6**

**An Ordinance To Approve Current Replacement Pages And To Adopt Certain Updates To The Village Of Golf Manor Codified Ordinances And Declaring An Emergency**

Periodically the Village updates its codified Ordinances which are maintained not only in print form, but electronically through our website. This Ordinance will update our Code to include those Ordinances which we had passed since the last codification in 2017, as well as to update our Traffic Code and General Offense Code for those changes under Ohio law which our Police Department enforces within the Village.


This updated codification will include not only the Charter passed by the Village electorate, but as an example it will also include the Non-Discrimination Ordinance which was reaffirmed at the 2020 election. Council is asked to pass this Ordinance as an emergency so that our Code will be immediately updated to continue enforcement without interruption.

**3. Ordinance No. 2021-7**

**An Ordinance To Amend Appropriations For Current Expenses And Other Expenditures Of The Village Of Golf Manor For The Fiscal Year Ending December 31, 2021**

This Ordinance will update the budget and appropriations for fiscal year 2021 to reflect changes necessary as a result of a motor vehicle accident involving a police vehicle. The anticipated replacement of the vehicle offset by monies received from the insurance carrier will need to be appropriated to allow the purchase to occur and to keep the books and records balanced. Council is asked to adopt this Ordinance and waive the second and third readings so the appropriation amendment takes effect immediately.

**RESOLUTION NO. 2021-4**

**A RESOLUTION AUTHORIZING THE ADMINISTRATION TO APPLY FOR AND  
ADMINISTER FUNDING FROM THE AMERICAN RESCUE PLAN ACT OF 2021**

**WHEREAS**, Congress has enacted the American Rescue Plan Act of 2021 from which through federal, state and local management the Village of Golf Manor has been allocated funds to assist the Village to recover economically from the impact of the COVID-19 pandemic; and

**WHEREAS**, the Administration has requested, and Village Council does agree, to authorize the Village Administrator and/or Village Fiscal Officer to execute any and all documentation necessary to participate in the American Rescue Plan Act of 2021 and to expend such funds received for eligible expenses.

**NOW THEREFORE, BE IT RESOLVED** by the Council of the Village of Golf Manor, Hamilton County, Ohio, that:

**SECTION I.** Council does hereby authorize the Village Administrator and the Village Fiscal Officer to execute any and all documentation required, including an application, and if appropriate, a Participation Agreement, to allow the Village of Golf Manor to participate in funding allocated from the American Rescue Plan Act of 2021 to the Village of Golf Manor. All monies for which the Administration may apply and for which funds may be appropriated and expended shall be only those eligible expenses which may be identified in the rules and regulations associated with this program to the extent that such eligible expenses will assist the Village in recovering from the impact of the COVID-19 pandemic.

**SECTION II.** This Resolution shall be in full force and effect from and after its passage.



## ORDINANCE NO. 2021-6

### AN ORDINANCE TO APPROVE CURRENT REPLACEMENT PAGES AND TO ADOPT CERTAIN UPDATES TO THE VILLAGE OF GOLF MANOR CODIFIED ORDINANCES AND DECLARING AN EMERGENCY

**WHEREAS**, the Administration has recommended, and Council does concur, that the Codified Ordinances of the Village of Golf Manor should be updated through calendar year 2020 to codify Ordinances adopted by the Village Council; and

**WHEREAS**, certain provisions within the Codified Ordinances of the Village of Golf Manor also should be amended to conform with current State law as required by the Ohio Constitution; and

**WHEREAS**, the various Ordinances of a general and permanent nature which have been adopted by Council since the last codification, including the updated Charter, should be included in the Codified Ordinances; and

**WHEREAS**, the City has heretofore entered into a contract with the Walter H. Drane Company to prepare and publish such revision which is before Council;

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the Village of Golf Manor, Hamilton County, Ohio, that:

**SECTION IV.** This Ordinance is hereby declared to be an emergency measure necessary for the preservation of the public peace, health and safety of the Municipality and its inhabitants for the reason that there exists an imperative necessity for the earliest publication and distribution of current Replacement Pages to the officials and residents of the Municipality, so as to facilitate administration, daily operation and avoid practical and legal entanglements.



**ORDINANCE NO. 2021 - 7**

**AN ORDINANCE TO AMEND APPROPRIATIONS FOR CURRENT EXPENSES

**SECTION II.** This Ordinance shall take effect the earliest opportunity as allowable by law.


