The following legislation is on the Agenda for the April 15, 2024 meeting of Village Council:

#### 1. Resolution 2024-5

A Resolution Establishing a Policy for the Flying of Flags by the Village of Golf Manor on Village-Owned or Maintained Properties

By this Resolution the Village would be establishing a policy for the flying of flags on Village properties which would allow for the flying of County, State, and City flags, as well as commemorative flags. By adopting this policy we are not establishing the flying of flags as a public forum for free speech, but rather for the expression of government speech.

### 2. **Resolution No. 2024-6**

A Resolution Declaring the Necessity of Levying A Tax In Excess Of The 10-Mill Limitation Equal To 7.0 Renewal Mills And Requesting The County Auditor To Certify Matters In Connection Therewith And Declaring An Emergency

This is the first step in the process of setting a 7.0 Renewal levy on the ballot for current Village expenses. It will be on the ballot for the November 5<sup>th</sup>, 2024 election. The deadline for filing a Resolution and delivering it to the Board of Elections is August 7, 2024. This initial Resolution will be sent to the Auditor's Office, who will certify the amount to us that will be collected from the levy. We then pass the Resolution to add the levy to the ballot and deliver it to the Board of Elections by August 7th.



# 2. Ordinance No. 2023-2

An Ordinance To Approve Current Replacement Pages To The Golf Manor Codified Ordinances And Declaring An Emergency

Periodically, we are required to update our Code of Ordinances to incorporate Ordinances the Village has passed, but also to incorporate updates to the State laws which are reflected in our Code of Ordinances. Council is asked to adopt this Recodification, which will then update the online version of our Code through American Legal Publishing. Council is asked to pass this legislation as an emergency and to suspend the second and third reading so that changes may be implemented immediately.

## **RESOLUTION NO. 2024 - 5**

# A RESOLUTION ESTABLISHING A POLICY FOR THE FLYING OF FLAGS BY THE VILLAGE OF GOLF MANOR ON VILLAGE-OWNED OR MAINTAINED PROPERTIES

WHEREAS, the Village Council desires to establish clear guidelines regarding the display of all flags flown on Village-owned or Village-maintained properties; and

WHEREAS, in adopting this policy the Village of Golf Manor the Village is not establishing the flying of flags by the Village to be a forum for free expression by the public, but rather as a non-public forum for the display of any governmental and non-governmental flag authorized by the Village Council either required by law or as an expression of the Village Council's official government speech.

NOW, THEREFORE, BE IT RESOLVED by the Council of the Village of Golf Manor that:

**SECTION I**: Flags shall be displayed in accordance with Federal and State statutes and regulations, including but not limited to, United States Code, Title 4, Chapter 1 and Ohio Revised Code Section 5.012.

**SECTION II** Village Flag. The Village of Golf Manor flag shall fly at half-staff if either the United States or Ohio flag is at half-staff. The Mayor may order the Village of Golf Manor flag to fly at half-staff at the death of a current or former Council Member, current Village staff member, or a historically significant member of the community, or in the event of a catastrophic event for which the Mayor deems flying the flag at half-mast is warranted.

# **SECTION III** Commemorative Flag

- 1. As an expression of the City's official government speech, the City Council may authorize, by majority vote, the display of a commemorative flag to fly on one or both of the smaller poles on either side of the front door of the Municipal building.
- 2. The Village Council may only consider a request to display a commemorative flag if the request is made by a member of the Village Council. Requests to fly a commemorative flag by members of the public will not be considered.
- 3. The decision to approve or deny a request to display a commemorative flag shall be made at a regularly scheduled Council meeting.
- 4. Commemorative flags shall be displayed for a period of time that is reasonable or customary for the subject that is to be commemorated.

- 5. Commemorative flags must be either purchased by the Village or temporarily donated for the Village's use and must be clean, without holes and tears and be made of an all-weather material.
- 6. Commemorative flags must be the same size or smaller than the United States and Ohio flags that are flown.
- 7. If any other flag is flown at half-staff, if practical the commemorative flag will also be flown at half-staff.
- 8. A "commemorative flag" as defined in this Policy shall mean a flag that identifies with a specific historical event, cause, nation, or group of people that the Village Council chooses to honor or commemorate consistent with the Village's mission and priorities.
- 9. The following are not allowed as commemorative flags and will not be considered by the Village Council:
- a. In order to avoid the appearance of Village government endorsing religion or a particular religious movement, flags of a particular religious movement or creed;
- b. In order to avoid the appearance of Village government endorsing a political party, flags of a political party;

and

c. Flags advocating a certain outcome in an election.

SECTION IV.	inis Resolution shall be in full force and effect from and after its passage.

# **RESOLUTION NO. 2024 - 6**

# A RESOLUTION DECLARING THE NECESSITY OF LEVYING A TAX IN EXCESS OF THE 10-MILL LIMITATION EQUAL TO 7.00 RENEWAL MILLS AND REQUESTING THE COUNTY AUDITOR TO CERTIFY MATTERS IN CONNECTION THEREWITH

**WHEREAS** this Council anticipates levying a tax in excess of the 10-mill limitation as described herein; and

**WHEREAS,** pursuant to Section 5705.03 of the Ohio Revised Code, this Council is required to certify to the County Auditor a Resolution requesting the County Auditor to certify certain matters in connection with such a tax levy.

**NOW THEREFORE, BE IT RESOLVED** by the Council of the Village of Golf Manor, Ohio, that:

# SECTION I.

Pursuant to provisions of Section 5705.19 of the Ohio Revised Code, it is necessary that a tax be levied in excess of the 10-mill limitation for the benefit of the Village of Golf Manor for the purpose of current expenses of the subdivision, at a rate not exceeding 7.00 mills for each One Dollar (\$1.00) of valuation which amounts to Seven Dollars (\$7.00) for each One Thousand Dollars (\$1,000.00) of valuation for a period of five years which is a *renewal* of an existing 7.00 mill levy.

# SECTION II.

This renewal of an existing 7.00 mill levy is not an increase in taxes and shall be levied on all real property located within the Village of Golf Manor, which is sited solely within Hamilton County, Ohio.

### SECTION III.

The question of the passage of said tax levy shall be submitted to the electors of the Village at the General Election to be held on November 5, 2024. If approved by a majority of the electors voting at such election, said tax levy shall first be placed upon the 2024 tax list and duplicate for first collection in the calendar year 2025.

# **SECTION IV.**

Pursuant to Section 5705.03 of the Ohio Revised Code, the County Auditor is hereby requested to certify to this Council the total current tax valuation of the Village of Golf Manor and the dollar amount of revenue that would be generated by the number of mills specified in Section 1 hereof, and the Clerk of Council is hereby directed to certify forthwith a copy of this Resolution to the County Auditor at the earliest possible time so that the County Auditor may certify such matters in accordance with such Section 5705.03 to be able to

appropriately consider, pass and file a Resolution of necessity for consideration at the November 5, 2024 General Election.

**SECTION V.** This Resolution shall be in full force and effect from and after its passage.
