Second by Mr. Fischer. All voted in favor.</p>

Minutes to be Approved	Committee minutes: Feb 17, 2026	<p>Motion to table the minutes approval to the May meeting by Mr. Michelson. Second by Ms. Chesser. All voted in favor</p>
New Business	<ul style="list-style-type: none"> • Compensation for employees in service and police depts, pay bands. 	<p>Mr. Michelson explained the background of the PD 6% increases over 3 years. 2026 is the second of those 3 years. Current pay bands prevent the increases from being implemented. Mr. Michelson asks for a recommendation to council to approve the bands by ordinance.</p> <p>Mr. Michelson asks that the Committee reviews the increases for the next meeting.</p> <p>Service Dept requests 3 types of positions, FT, PT, and Seasonal. They are also asking for another full-time employee. The increase for pay only would increase by about \$25,000.</p>

	<ul style="list-style-type: none"> • Review of Solicitor billing • Technology • Finance Packet for March 	<p>Another FT employee is another \$60,000. Mr. Michelson asks for a band to determine annual increases, instead of a one-time vote, which would leave employees without a raise until the next threshold.</p> <p>Mr. Fischer asked Mr. Pridonoff to provide a spreadsheet of current pay for service employees.</p> <p>Mr. Michelson discussed the necessity to meet over the phone instead of in-person, to avoid travel costs; he also discussed the review of contracts that have not moved forward, specifically citing IT services.</p> <p>Mr. Michelson discussed the need to purchase equipment for council members.</p> <p>Motion Mr. Fischer to refer finance packet to full council. Second by Mr. Michelson. All voted in favor.</p>
